Pitch Drainage	It has been established that drainage problem was not fully resolved, further to an insurance claim several years ago. Insurers have agreed further works are required. The insurers are establishing whether a new claim is to be made or works to be carried out though the previous claim. As the claim has to be perused by the Landlords (Totton College), the club has limited input.	A further update is anticipated by: End November 2024.
